Mr. William Garay, Director of Finance, provided a brief report on eight parcels of vacant land and summarized their appraisal valuation. Mr. Garay stated that the properties would be disposed of by sale through a broker approved by the City of San Bernardino. Mr. Garay further noted that the funds retained from the sale of the properties will be provided to the State of California Auditor-Controller.

Chairman Douglas Headrick inquired if the properties listed are within the boundaries affected by Measure O legislation. Vice Chairman Michael Burrows replied no and stated that these properties are zoned as either Multiple Residential or Neighborhood-Commercial.

Mr. David Reck questioned if the Agency would need to list the properties publicly. Vice-Chairman Burrows confirmed that the listing will be consistent with the City of San Bernardino's public advertising methods.
